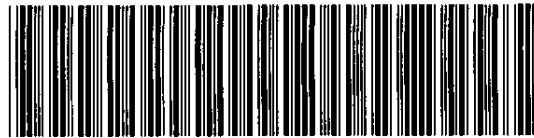


ARTICLES OF ORGANIZATION FOR LIFE DEVELOPMENT GROUP, LLC
