AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF WERMUTH PANELL & ORTIZ, PLLC

The undersigned, being the authorized representative of a member of Wermuth Panell & Ortiz, PLLC, hereby files these duly executed Amended and Restated Articles of Organization of Wermuth Panell & Ortiz, PLLC. pursuant to the Florida Revised Limited Liability Company Act, Chapter 605. ARTICLE I. NAME

ARTICLE VII. MANAGEMENT

This Company will be managed by one or more managers appointed by the members in accordance with the terms of the Operating Agreement. As such, the Company will be manager-managed. The initial managers shall be J. Michael Wermuth, Eli Panell, Roberto Ortiz, and Astrid Wermuth.

ARTICLE VIII. <u>INCORPORATION OF CHAPTER 621, FLORIDA STATUTES</u>

This Company is intended to be a Professional Limited Liability Company within the meaning of the Act, and accordingly, the Company, its Members, Managers, and Officers shall be subject to all of the Sections of the Act concerning the formation of the Company, the conduct of its business, and all the liabilities, rights, privileges and immunities of the Company, its Members, Managers, and Officers, as stated in the Act.
