2. The amendment to the Articles of Organization being effected hereby will completely delete Article IV of the Articles of Organization as of the date hereof, and substitute in its place the Article IV set forth below.

4. These Articles of Amendment to the Articles of Organization shall be effective immediately upon filing by the Secretary of State of the State of Florida, and thereafter, Article IV of the Articles of Organization of the Corporation shall read as follows:

All powers of the limited liability company shall be exercised by or under the authority of, and the business and affairs of the limited liability company shall be managed by or under the direction of the managers of the limited liability company. The Board of Managers of this limited liability company shall consist of a number of persons
