**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF
RPB1, LLC**

Pursuant to the provisions of Section 605.0202, Florida Statutes, **RPB1, LLC**, a Florida limited liability company (the "Company"), adopts the following Articles of Amendment to its Articles of Organization:

1. The name of the Company is **RPB1, LLC**.
2. The Articles of Organization were filed on April 28, 2016 and assigned document number L16000084195.
3. Article IV of the Articles of Organization of the Company is hereby amended in its entirety to read as follows:
