

**ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION  
OF HILL 1902, LLC**

**THE UNDERSIGNED** hereby executes and swears to these Articles of Amendment to Articles of Organization of HILL 1902, LLC, a Florida limited liability company (the "Company"), pursuant to the Florida Revised Limited Liability Company Act, as amended (the "Act"), Florida Statutes § 605.0202:

1. **Name of Company.** The name of the Company is HILL 1902, LLC (Florida Document Number L16000084459).

2. **Date of Filing of Articles of Organization.** The Company filed with the Florida Department of State Articles of Organization with an effective date of May 2, 2016 (the "Articles").

3. **Amendments to Articles of Organization.** Section 1. of the Articles is hereby amended by deleting the current Section 1. in its entirety and substituting the following in lieu thereof:

"1. Name. The name of this limited liability company is **HILL 1898, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida (the "Act")."

4. **Effective Date of Amendment.** The effective date of these Articles of Amendment to Articles of Organization shall be May 19, 2017.
