The undersigned, Ross S. Orenstein, a natural person competent to contract and a member of Music as Message, LLC, hereby presents these Articles of Organization as the Articles of Organization of Music as Message, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is Music as Message, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

ARTICLE III - PURPOSE AND POWERS

The initial registered office of the Company is 17 South Palafox Place, Pensacola, Florida 32502, and the name of the registered agent at that address is Ross S. Orenstein.


ARTICLE VI - MANAGEMENT


