

Articles of Organization
of
13593 Brynwood, LLC
A Florida Limited Liability Company

1. **Name.** The name of this limited liability company is 13593 Brynwood, LLC (the "Company"), and it shall be formed as a Florida limited liability company under Chapter 605, Florida Statutes.
2. **Duration.** The Company shall exist from the date of filing of these Articles of Organization with the Florida Secretary of State, and the Company's existence shall be perpetual.
3. **Purpose.** The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of the State of Florida.
4. **Place of Business.** The mailing address and street address of the Company's principal office is 15301 Orange River Road, Fort Myers, Florida 33905.
5. **Registered Agent and Office.** The name of the initial registered agent of the Company is Lowell S. Schoenfeld. The street address of the initial registered agent of the Company is 1380 Royal Palm Square Boulevard, Fort Myers, Florida 33919.
6. **Management of the Company.** The Company shall be managed by a manager or managers and is, therefore, a manager-managed company. Charles C. Bundschu, III and Gayle P. Bundschu shall serve as initial Managers of the Company.
7. **Operating Agreement.** The members shall have the power to adopt, alter, amend, or repeal an Operating Agreement for the Company containing provisions for the regulation and management of the affairs of the Company.
8. **Voting.** The Company is authorized to issue membership units with voting rights and membership units without voting rights.
9. **Certificated Interests.** The members' interests in the Company may be evidenced by certificates.


