The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 605, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be SCOMB ENTERTAINMENT LLC ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 5013 Monet Avenue, Orlando, Florida 32812 and the mailing address shall be the same.

ARTICLE 3 - EFFECTIVE DATE

ARTICLE 4 - DURATION

These regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.
