Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act, the undersigned, being a member of Pocydon Services, LLC (hereinafter the "Company"), a Florida limited liability company, does hereby certify:

**FIRST:** The Articles of Organization of the Corporation were originally filed with the Secretary of State of Florida on May 6, 2016, document number L16000087087.

**SECOND:** These Amended and Restated Articles of Organization, which supersede the original Articles of Organization and all amendments to them, were adopted by the members of the Company on February 27, 2018. To effect the foregoing, the text of the Articles of Organization is hereby restated and amended as herein set forth in full:
