**ARTICLE I.
NAME OF LIMITED LIABILITY COMPANY**



The Limited Liability Company created and formed by the filing of these Articles of Organization shall be a member-managed company. Duke Tunstall is the initial Managing Member.

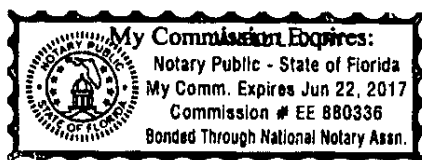


