ARTICLE V -- CAPITAL CONTRIBUTIONS

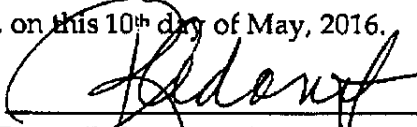
