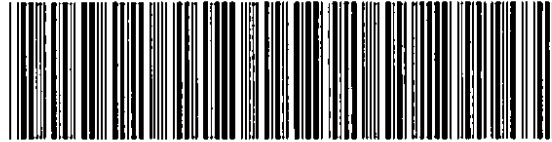

TRANSFER AGREEMENT

THIS AGREEMENT made this 25th June day of June, 2021, by and between ROGER T. HOYLE ("HOYLE"), and DWIGHT N. HARTLEY ("HARTLEY").

WITNESSETH:

WHEREAS, HOYLE and HARTLEY created a Florida limited liability company known as GOOD LIFE LAWN AND LANDSCAPING, LLC. (the "Company") . Document Number L160000010, in which they each owned an equal share of the Membership Interests; and

WHEREAS, HARTLEY wishes to transfer all membership interest he may have in the Company to HOYLE and withdraw as a Member from the Company; and

WHEREAS, on July 1, 2020, HOYLE filed an Amended Annual Report with the Florida Division of Corporations naming himself as the sole member of the Company; and

WHEREAS, HOYLE is willing to indemnify and hold HARTLEY harmless for liabilities occurring after July 1, 2020; and

WHEREAS, the parties desire to reach an agreement acceptable to all parties.

NOW, THEREFORE, in consideration of the mutual covenants and agreements herein stated, it is mutually agreed by and between the parties as follows:

1. TRANSFER AND WITHDRAWAL. HARTLEY does grant, convey, assign, transfer and set over unto HOYLE, and the heirs, administrators, successors and assigns of HOYLE, all of HARTLEY's right, title and interest as a Member of said Company, in accordance with the Articles of Organization, pursuant to which the Company is constituted. The parties confirm the withdrawal of HARTLEY as a member of the Company.

2. HOLD HARMLESS. HOYLE does and shall indemnify, save, hold harmless and reimburse HARTLEY from and against any and all losses, claims, damages, liabilities, fees and costs, and all other expenses or debt related to, growing out of, or arising from the Company or HOYLE, including but not limited to court costs and attorneys fees, after July 1, 2020.

3. BINDING EFFECT. All the provisions of this Agreement shall be binding upon and shall inure to the benefit of the respective heirs, beneficiaries, guardians, executors, personal representatives, administrators and assigns of the parties hereto.

4. ENTIRE AGREEMENT. Each party understands and agrees that this Agreement constitutes the entire contract between the parties and supersedes any prior understandings or agreements between them. There are no agreements or representations other than as hereinabove set forth.

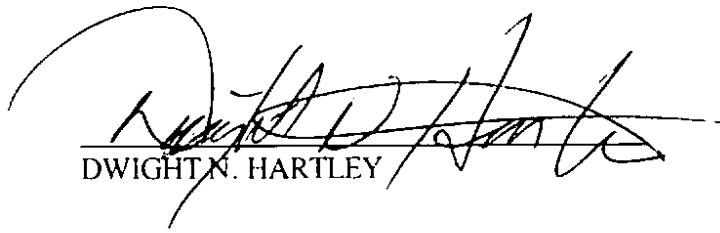
