

The undersigned, for the purposes of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 605, hereby make, acknowledge and file the following Articles of Organization.

## **ARTICLE I - NAME**

The name of the limited liability company shall be Biophab Innovations LLC ("Company").

# **ARTICLE II - ADDRESS**

The mailing address and street address of the principal place of business of the Company in Florida shall be 3100 Del Prado Boulevard S., #308, Cape Coral, FL 33904.

The Company shall be a member managed company.
