Brayton, III, a natural person competent to contract and, in his capacity as Personal Representative of the Estate of Mary Louise Brayton, the initial member of 1209 Panferio, LLC, hereby presents these Articles of Organization as the Articles of Organization of 1209 Panferio, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is 1209 Panferio, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE VI - MANAGEMENT

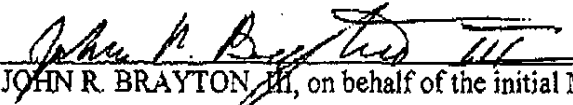

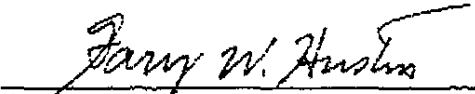
