ARTICLES OF ORGANIZATION OF MIAMI VENTURES, LLC

The undersigned, Jennifer Donnelly, a natural person competent to contract and a member of Miami Ventures, LLC, hereby presents these Articles of Organization as the Articles of Organization of Miami Ventures, LLC, a limited liability company formed under the provisions of Chapter 605, Florida Statutes.
