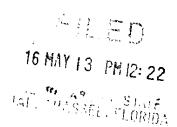

ARTICLES OF ORGANIZATION OF SPUMANTE LLC



A FLORIDA LIMITED LIABILITY COMPANY

ARTICLE I-NAME

The name of the limited liability company is Spumante LLC (the "Company").

ARTICLE II—ADDRESS AND PLACE OF BUSINESS
