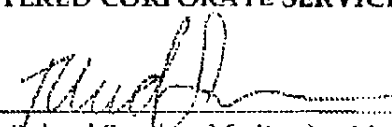

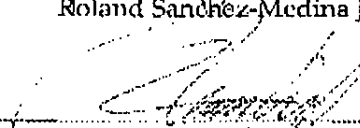
ARTICLE IV -- MANAGER-MANAGED
