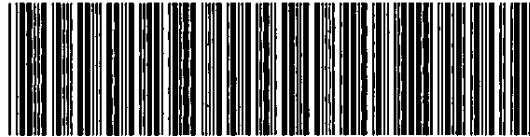




ARTICLE II
