I, Andrew Linley, make this affidavit upon personal knowledge of the facts described below or upon reasonable inquiry, and swear that the following information is true and correct to the best of my knowledge, information, and belief:

1. I am the Senior Vice President of Finance and Treasurer at US LBM Holdings, LLC.  
I am over the age of 18 and competent to make oaths.

2. UBS LBM Holdings, LLC is a limited liability corporation with its principal place of business at 2077 Convention Center Concourse, Suite 125, Atlanta, GA 30337.

3. Raymond Building Supply LLC ("Raymond Building Supply") is a subsidiary of US LBM Holdings, LLC.

4. Raymond Building Supply is a Florida limited liability corporation with its current principal place of business at 7751 Bayshore Road, North Fort Myers, FL 33917. Its FEIN is 59-1483473.

5. It is my understanding that the business information of Raymond Building Supply is required to be registered on Sunbiz.org. As stated on the homepage of Sunbiz.org, this website is an official State of Florida website.

6. Mike Stevens is the President and General Manager of Raymond Building Supply.  
Mike Stevens is an Authorized Person of Raymond Building Supply.

7. Mike Barr is the Vice President of Operations of Raymond Building Supply. Mike Barr is an Authorized Person of Raymond Building Supply.

8. When Mike Stevens and/or Mike Barr sign any filing to be submitted to Sunbiz.org, including a 2023 Florida Limited Liability Company Amended Annual Report or amendments to such filing, they electronically sign the document as an Authorized Person of Raymond Building Supply. They also certify as to the following: "I hereby certify that the information indicated on this report or supplemental report is true and accurate and that my electronic signature shall have the same legal effect as if made under oath; that I am a managing member or manager of the limited liability company or the receiver or trustee empowered to execute this report as required by Chapter 605, Florida Statutes; and that my name appears above, or on an attachment with all other like empowered."

9. CT Corporation System is the Registered Agent of Raymond Building Supply. CT Corporation System is located at 1200 South Pine Island Road, Plantation, FL 33324. CT Corporation System has served as the Registered Agent of Raymond Building Supply since 2016.

10. On May 8, May 15, May 24, and May 30, 2023, an individual(s) broke into Raymond Building Supply's locked mailbox at headquarters at 7751 Bayshore Rd, North Fort Myers, FL 33917. On June 12, 2023, Raymond Building Supply discovered that locked mailboxes had also been broken into at its Naples, North Port, and North Fort Myers locations in Florida. The addresses of those locations are 3455 Beck Blvd Naples, Florida 34114, 2233 Murphy Court North Port, Florida 34289, and 7751 Bayshore Rd, North Fort Myers, FL 33917, respectively.

11. The individual(s) who broke into the locked mailboxes stole checks and other mail addressed to Raymond Building Supply and used these stolen items to open bank accounts in Raymond Building Supply's name at JP Morgan Chase Bank, SouthState Bank, Synovus Bank,

and Truist Bank. This individual(s) has continued to attempt to open accounts at other major banks as well.

12. Raymond Building Supply is actively working to identify and to confirm the precise loss amount. To date, approximately \$290,000 of stolen customer funds has been deposited in fraudulent bank accounts, with multiple other checks pending.

13. Since May 16, 2023, individual(s) not authorized by Raymond Building Supply have fraudulently altered the entity registration records of Raymond Building Supply on Sunbiz.org on a repeated basis, which has forced Raymond Building Supply to file amended reports containing accurate business information with the Secretary of State to replace the fraudulent amended reports.

14. The perpetrator(s) have fraudulently amended Raymond Building Supply's business records on Sunbiz.org on the following dates in the year 2023: May 16, May 17, May 22, May 23, May 31, June 1, June 2, June 5, June 8, June 9, June 11, and June 12. The perpetrator(s) who fraudulently changed Raymond Building Supply's business records on Sunbiz.org on these dates have used the following FEINs in their fraudulent filings: 92-1366610, 93-1366610, 93-1595754, and 93-1786129. They have used two inaccurate addresses as the current mailing address of the business and address of the Authorized Person: 231 Grenada Blvd., Fort Myers, FL 33905, and 3360 Kenmore Dr., Sarasota, FL 34261. They have used the identities of "Benjamin Wood Jr.," "Joseph S. Martin," and "Jason Warner" as the Registered Agent and Authorized Person of Raymond Building Supply, despite none of these individuals being a Registered Agent or Authorized Person of Raymond Building Supply.

15. Attached hereto as Exhibit A is a true and complete copy of a fraudulently filed 2023 Florida Limited Liability Company Amended Annual Report, downloaded from Sunbiz.org, that

had been filed on Sunbiz.org on May 16, 2023, reference number 7044928049CC. This report was electronically signed by an individual named “Joseph S. Martin” who is not an Authorized Person or Registered Agent of Raymond Building Supply. This report contains inaccurate information, including inaccurate: mailing address, FEIN, registered agent information, and authorized person(s) detail. This report should be VOIDED.

16. Attached hereto as Exhibit B is a true and complete copy of a fraudulently filed 2023 Florida Limited Liability Company Amended Annual Report, downloaded from Sunbiz.org, that had been filed on Sunbiz.org on May 17, 2023, reference number 5471254488CC. This report contains inaccurate information, including inaccurate: mailing address, FEIN, registered agent information, and authorized person(s) detail. This report should be VOIDED.

31. As a result of the fraudulent activity described above, the perpetrator(s) has successfully opened multiple banking accounts under his or her control, causing Raymond Building Supply to lose in excess of \$290,000 in customer funds that were inappropriately diverted to the fraudulently opened bank accounts.

32. On May 30, 2023, Raymond Building Supply notified the Lee County Sheriff's Office about the theft of checks and mail from Raymond Building Supply's mailbox and that a criminal actor(s) has fraudulently been amending the registered agent information of Raymond Building Supply on Sunbiz.org on a repeated basis, using this fraudulent information to open bank accounts in Raymond Building Supply's name, and then depositing stolen funds from customers and vendors into these bank accounts. Raymond Building Supply has been cooperating with the Lee County Sheriff's Office investigation into this ongoing criminal activity. The Lee County Sheriff's Office has opened an investigation into this matter, with the case number 23-239256.

33. Beginning on May 30, 2023, Raymond Building Supply repeatedly has contacted the Division of Corporations of the Florida Department of State to inform it about this criminal activity and request assistance with preventing the perpetrator from continuing to file fraudulent



registration information on Sunbiz.org.

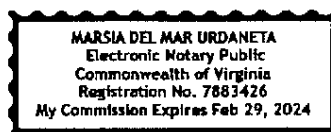
