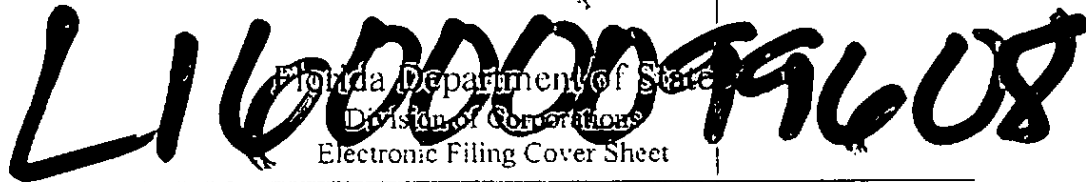

ARTICLES OF AMENDMENT TO THE ARTICLES OF ORGANIZATION
of
IMAG PROPERTIES LLC

These Articles of Amendment are unanimously adopted by all Members of the company to amend the Articles of Organization, to be filed with the Florida Department of State, as follows:

ARTICLE ONE: NAME

The name of the company is IMAG Properties LLC.

ARTICLE TWO: DATE OF FILING

The Articles of Organization were filed on 18 May 2016 and were effective on that same day.

ARTICLE THREE: AMENDMENT


The Articles of Organization are amended by replacing Article IV in its entirety with the following:

ARTICLE IV

The Company shall be a manager-managed Company and it shall be managed by one or more Managers appointed by the Members in accordance with the Operating Agreement.

Until and unless changed by the Members in accordance with the Operating Agreement, the Company shall have two Managers and those Managers are Christopher Hardisty, whose address is 5 Wodenethe Dr S, Beacon, NY 12508, and Kellie Hardisty, whose address is 5 Wodenethe Dr S, Beacon, NY 12508. Any Manager may be removed and other or additional Managers appointed by the Members in accordance with the Operating Agreement; provided, however, that the Company shall always have at least one Manager.
