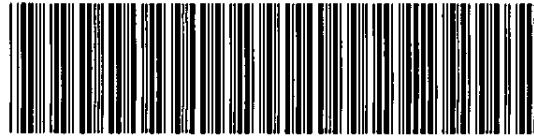

Pursuant to the provisions of Chapters 607 and 605, Florida Statutes, these Articles of Conversion and attached Articles of Organization are submitted to convert J. Dean Cole, Inc., a Florida corporation (the "Corporation"), into Jewett Partners, LLC, a Florida limited liability company (the "LLC").

1. The Articles of Incorporation of the Corporation were duly filed with the Florida Secretary of State on August 7, 1996, effective July 31, 1996, and were amended and restated on January 5, 2004, effective January 1, 2004. The Florida document number for the Corporation is P96000066721.

2. The name of the Corporation prior to conversion to a limited liability company is J. Dean Cole, Inc.

3. The name of the limited liability company into which the Corporation will convert, as provided by the attached Articles of Organization, shall be Jewett Partners, LLC.

4. The address of the LLC as set forth in the attached Articles of Organization is 500 Lakeview Street, Orlando, Florida 32804.

5. The plan of conversion was approved by the shareholders and directors of the Corporation as required by Chapter 607, Florida Statutes.


6. The effective date of the conversion shall be the date of filing these Articles of Conversion with the Florida Secretary of State.






