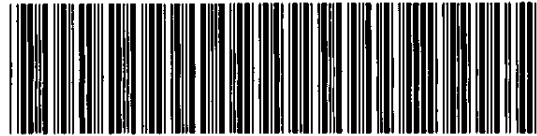

The Company's name is BibleJourney, LLC. The Company is manager-managed. Bryan J. Dolan and Timothy S. Laniak are the initial managers of the Company.


