**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION**

OF

FOREVER 168, LLC

Pursuant to the provisions of the Florida Statutes Section 608.411, FOREVER 168, LLC, a Florida Limited Liability Company, whose Articles of Organization were filed with the Florida Dept. of State on May 27, 2016, hereby adopts the following Amended and Restated Articles of Organization of the Company. These Amended and Restated Articles of Organization were adopted by the unanimous written consent of all members and managers of the Company on June 10, 2016. We further declare that the following Articles shall serve as the Charter and authority for the conduct of business of the limited liability company.

**ARTICLE I
NAME AND PRINCIPAL PLACE OF BUSINESS**

The name of the limited liability company shall be RICK K. CHANG, LLC, and the address of its principal office is 7712 Latrobe Court, Bradenton, FL 34202 and the mailing address is 7712 Latrobe Court, Bradenton, FL 34202 in the County of Manatee, State of Florida, but it shall have the power of authority to establish branch offices at any other place or places as the members may designate.

**ARTICLE II
PURPOSES AND POWERS**

In addition to the powers authorized by the laws of the State of Florida for limited liability companies, the general nature of the business or businesses to be transacted, and which the limited liability company is authorized to transact, shall be to engage in any activity or business authorized under the Florida statutes, and as further defined in the Company's Operating Agreement.

This limited liability company is to be initially managed by one (1) or more Managers.


**ARTICLE IV
