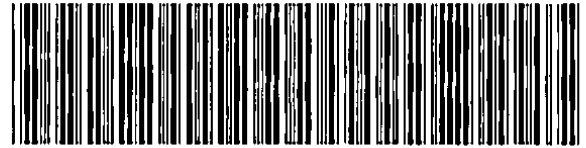

FIFTH: The Plan of Merger was adopted by the sole member of the Merging Company in accordance with Section 605.1023 of the Act on November 13, 2020.


