ARTICLES OF ORGANIZATION

for

DUNN- RINEHART CENTER, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, hereby make, acknowledge, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be Dunn- Rinehart Center, LLC ("Company")

ARTICLE II - STREET ADDRESS

ARTICLE X - INDEMNIFICATION

The company shall indemnify its members, managers, officers, employees, and agents to the full extent permitted by law.
