The name of the limited liability company shall be "**WATERSOUND PARKWAY, LLC**" (hereinafter referred to as the "**Company**").


ARTICLE II - PRINCIPAL OFFICE & MAILING ADDRESS

The street address and mailing address of the principal office of the Company is 133 South WaterSound Parkway, WaterSound, Florida 32413.


ARTICLE III - REGISTERED AGENT
