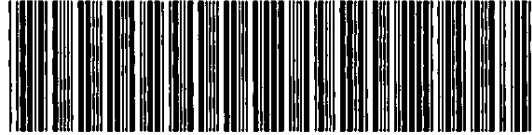

**ARTICLES OF ORGANIZATION**  
**FOR**  
**GOPHER NOLE, LLC**  
**(A Florida Limited Liability Company)**

**ARTICLE I**  
**NAME & EFFECTIVE DATE**

A. The name of the Limited Liability Company is *GOPHER NOLE, LLC* (the "Limited Liability Company").
