ARTICLE I Name and Principal Place of Business

The name of this limited liability company is BRIGHT FUTURES HOME CHILD CARE, LLC; the physical address of its principal office is 2011 Dockside Drive, Valrico, Florida 33594, and its mailing address is 2011 Dockside Drive, Valrico, Florida 33594.

ARTICLE II Purposes


