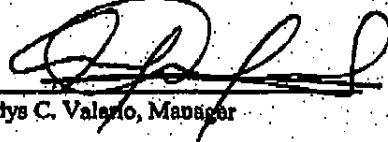

SECOND: The Articles of Organization were filed on June 2, 2016 and were assigned document number L16000107594.

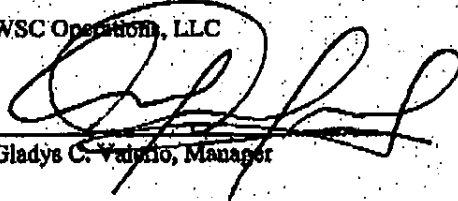
