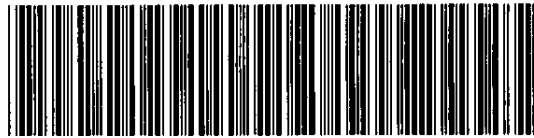

FOR

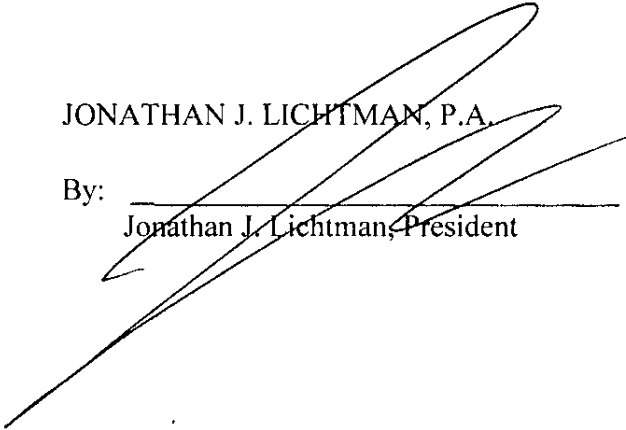
