**ARTICLES OF ORGANIZATION
OF
COASTAL INVESTMENTS OF PCB, LLC**

The undersigned, Matthew A. Brandman, a natural person competent to contract and a member of Coastal Investments of PCB, LLC, hereby presents these Articles of Organization as the Articles of Organization of Coastal Investments of PCB, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is Coastal Investments of PCB, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The street address of the Company's initial principal office is 19715 Panama City Beach Parkway, Panama City Beach, Florida 32413. The Company's initial mailing address is 19211 Panama City Beach Parkway, PMB 169, Panama City Beach, Florida 32413. The Company's principal office may hereafter be at such other place or places as its members from time to time may determine.

ARTICLE III - PURPOSE AND POWERS

The Company is organized for any legal and lawful purpose for which a limited liability company may be organized and shall have all powers and rights which a limited liability company may exercise pursuant to Chapter 605, *Florida Statutes*.

The date for commencement of the Company's existence shall be the date these Articles of Organization are filed with the Florida Department of State. The Company shall have a perpetual existence unless the Company is terminated as provided in its Operating Agreement.

ARTICLE V - REGISTERED OFFICE AND AGENT


ARTICLE VI - MANAGEMENT
