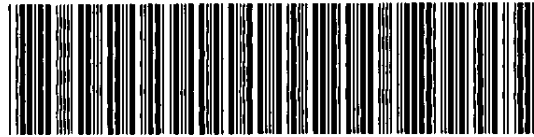

TERMINATION OF EXISTENCE

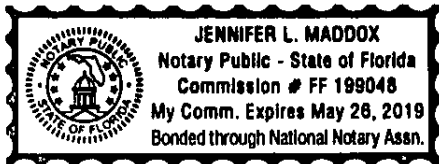
