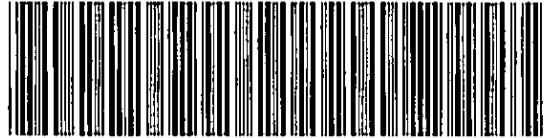


ARTICLE 3. EFFECTIVE DATE OF THE DISSOLUTION.
