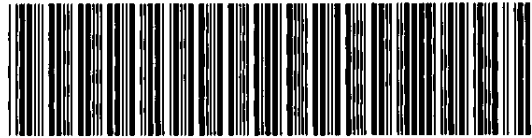

The Articles of Organization following are adopted for the purpose of organizing a Company under the Florida Limited Liability Company Act, Chapter 605, Florida Statutes.

ARTICLE I

Name and Address of Company

The name of the limited liability company is Winston Strategies, LLC, with its offices at 150 Acklins Circle #205, Daytona Beach, FL 32119.

ARTICLE II

Commencement and Duration of Company

The Company shall exist from the date of filing these Articles with the Florida Department of State until the occurrence of any of the events specified by the Florida Revised Limited Liability Company Act, unless continued by the unanimous consent of all of the remaining members.

ARTICLE III

Management

Edward J. Baum, whose address is 150 Acklins Circle #205, Daytona Beach, FL 32119, and Philip T. If a member of the Company dies, retires, resigns, is expelled, declared insane, becomes bankrupt, is dissolved or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the remaining members may, by unanimous written agreement, continue the business of the Company.
