ARTICLE II - Address

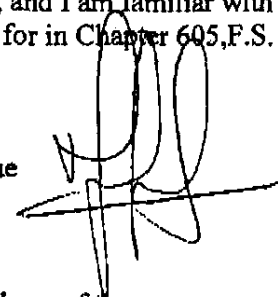

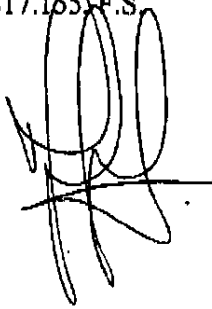
**ARTICLE VI – Members' Rights to Continue Business**
