**ARTICLES OF ORGANIZATION

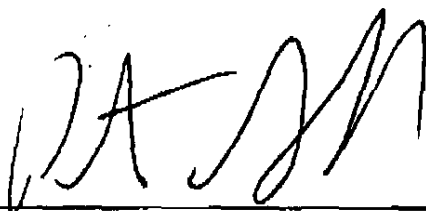
**ACCEPTANCE OF REGISTERED AGENT**
