# **ARTICLES OF ORGANIZATION**

### SOCIAL MEDIATORS, LLC.

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, F.S. Chapter 605, hereby makes, acknowledges, and files the following Articles of Organization.

# **ARTICLE I - NAME**

The name of the limited liability company shall be SOCIAL MEDIATORS, LLC. ("company").

# **ARTICLE II - ADDRESS**

The mailing address and street address of the principal office of the company is 1199 South Federal Highway, Suite 181, Boca Raton, Palm Beach County, Florida 33432.

### **ARTICLE III - DURATION**

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State or on another effective date if specified. The company's existence shall be perpetual unless the company is dissolved earlier as provided in these articles of organization or in the operating agreement regulations.

The company shall be dissolved on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by written unanimous vote of the remaining members.

The company shall be managed by its members in accordance with the operating agreement regulations adopted by the members for the management of the business and affairs of the company. These operating agreement regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization.


