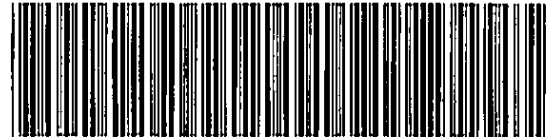

Changing the registered Agent back to Hal Uhrig. On May 20, Jayson Lopez, a legal stranger to the Company, filed a fraudulent and unauthorized Annual Report for the Company, changing the Registered Agent to himself, at his address. There was a notation (we assume made by the Department/Division) that the signature was "NOT AUTHORIZED". On September 26, 2019 the same Jayson Lopez filed a fraudulent and unauthorized Amendment to Articles of Organization of the Company, removing the lawful Members and Manager and changing the Registered Agent to Jayson Lopez. It appears that the attached 3 pages from a document of at least 8 pages, which appear to be from an Operating Agreement of another corporate entity. Jayson Lopez is not a Member of International Monetary Specialists, LLC and he has no authority whatsoever to file anything with the Division with respect to this company. The changes above reinstate the status quo [prior to the unauthorized actions of Jayson Lopez].


