**ARTICLES OF ORGANIZATION OF
P.T. HOFFMAN MEDIATIONS, PLLC**

The undersigned, PHILIP HOFFMAN, a natural person competent to contract and member of P.T. HOFFMAN MEDIATIONS, PLLC, hereby presents these Articles of Organization for the formation of a professional limited liability company under the provisions of Chapters 621 and 605, *Florida Statutes*.

ARTICLE I

The name of the professional limited liability company is:

This professional limited liability company is referred to in these articles of organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

ARTICLE III - PURPOSES AND POWERS

ARTICLE VIII - RESTRICTION ON MEMBERSHIP

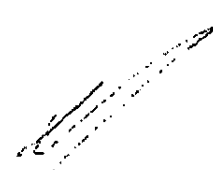
To the extent applicable, a member may not sell or otherwise transfer his or her interest in the Company, whether represented by membership units, certificates, or a percentage interest
