
1. The name of the limited liability company is HOMEPOCKET, LLC (the "LLC").
2. The Articles of Organization of the LLC were filed on June 16, 2016 and assigned document number L16000115411.
3. The dissolution was unanimously approved by the sole member of the LLC on December 27, 2017.
