# ARTICLES OF ORGANIZATION OF INTERNATIONAL EXECUTIVE SCHOOL OF EXCELLENCE COACHING, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Act, Florida Statutes Chapter 605, hereby makes, acknowledges, and files the following Articles of Organization.

# ARTICLE 1 - NAME

The name of the limited liability company shall be INTERNATIONAL EXECUTIVE SCHOOL OF EXCELLENCE COACHING, LLC, ("Company").

## ARTICLE 2 ~ ADDRESS

The principal place of business of the Company in Florida shall be 66 W Flagler Street 12<sup>th</sup> Floor, Miami, Florida 33130 and the mailing address shall be 1925 SW 82<sup>nd</sup> CT, Miami, Florida 33155.

# ARTICLE 3 - EFFECTIVE DATE

Subject to the provisions of Article 9, the Company's existence shall terminate no later than 99 years from its date of commencement, unless the Company is earlier dissolved as provided in these Articles of Organization.

# ARTICLE 5 - PURPOSES AND POWERS

The general purpose for which the Company is organized is to transact any and all lawful business for which a limited liability company may be organized under the laws

of the State of Florida. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

# ARTICLE 6 - REGISTERED AGENT AND REGISTERED OFFICE

#### ARTICLE 8 - TERMINATION OF EXISTENCE

The Company shall be dissolved upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or manager, or upon the occurrence of any other event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by the consent of all the remaining members, provided there are at least one remaining member.

# ARTICLE 9 - MANAGEMENT

The Company shall be managed by a manager(s) in accordance with regulations adopted by the members for the management of the business and affairs of the Company. These regulations may contain any provisions for the regulations and management of the affairs of the Company not inconsistent with law of these articles of Organization.
