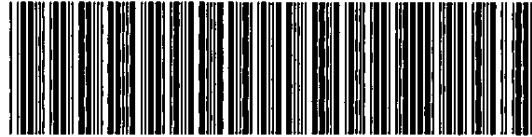

Articles of Organization of

a Florida Professional Limited Liability Company

The undersigned, **ROBERT J. As the sole initial member of the proposed professional limited liability company, he does hereby make and file these Articles of Organization, and hereby declares and affirms:

**ARTICLE I:
Name**

**ARTICLE II:


**ARTICLE V:

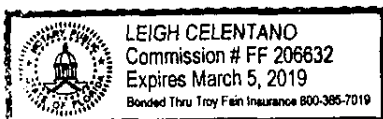




