The undersigned, acting as organizer of this professional limited liability company pursuant to Chapter 621 of the Florida Statutes and an attorney licensed to render services as such under the laws of the State of Florida, adopts the following Articles of Organization for such professional limited liability company:

ARTICLE I - NAME OF COMPANY

The name of the professional limited liability company is RICHARD D. WEST, P.L.L.C. (the "Company").

ARTICLE II - PRINCIPAL OFFICE
