ARTICLES OF ORGANIZATION FOR GE LAVOIE INVESTMENTS, LLC, A FLORIDA LIMITED LIABILITY COMPANY FILED PURSUANT TO FLORIDA STATUTE §605.0201

ARTICLE I

The name of the limited liability company is: GE LAVOIE INVESTMENTS, LLC.

ARTICLE II

ARTICLE III

The Company and the duration of its existence shall commence upon the filing of these Articles and shall continue indefinitely unless sooner terminated in accordance with the provisions of the Operating Agreement.

A member may not assign or transfer any portion of his or her interest in the Company without the prior written, unanimous approval of each member and then only in accordance with the Operating Agreement.

The net profits and losses of the Company for any year shall be allocated among the members in accordance with the Operating Agreement.
