#### ARTICLE 1 - NAME

The name of the limited liability company shall be **CUSTOM GLAZING CONTRACTORS LIMITED LIABILITY COMPANY** ("Company").

#### ARTICLE 2 - ADDRESS

**ARTICLE 9 - MANAGEMENT**




