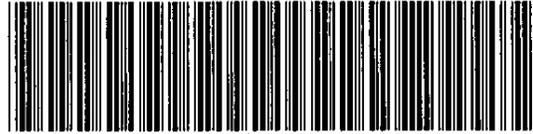

THE UNDERSIGNED, for the purpose of forming a limited liability company under the Revised Florida Limited Liability Company Act, Florida Statutes, Chapter 605 (the "Act"), hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE I - NAME**

The name of the limited liability company shall be **ROBERT W. LAPONTNY, LLC** (hereinafter called "Company"). The principal place of business of the Company in Florida shall be in Brevard County.

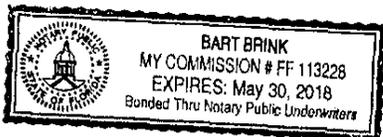
