ARTICLE II - PRINCIPAL OFFICE

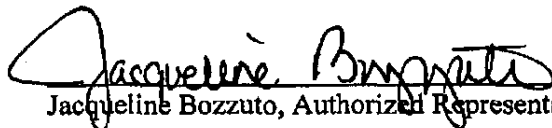
The mailing address and street address of the principal office of the Company is 7836 Sugar Bend Drive, Orlando, Florida 32819.

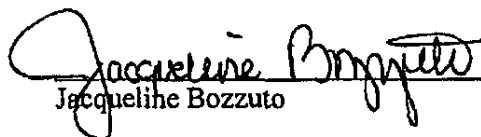
ARTICLE IV - MANAGEMENT
