ARTICLES OF ORGANIZATION

Pursuant to the provisions of Section 605, Florida Statutes, this Florida profit limited liability company adopts the following Articles of Organization:

ARTICLE I

The name of the limited liability company is FEMLIFE FOR LIFE, LLC.

ARTICLE II

The period of existence of the limited liability company shall be perpetual, commencing on the date the original Articles were filed.

ARTICLE V

The Operating Agreement of the limited liability company (hereinafter the "Company") contains provisions regarding:

1. The nature of the business to be transacted or the purposes to be promoted or carried out by the Company, which shall be to own, operate, manage, develop, and to otherwise undertake such activities as are determined by the Company with respect to its investments, development and management of its assets and the personal property of the Company which is located at its principal place of business or is used in connection therewith, and all business of the Company relating thereto, and for

- 2. The rights of the Members to admit additional Members and the terms and conditions of the admissions If the Operating Agreement is silent as to the admission of additional Members, then the Members of the Company shall be permitted to admit additional members upon approval of Members owning One Hundred percent (100%) of the outstanding Membership Interests of the Company. In such event, the terms and conditions required of new Members shall be determined at that time by a vote of the Members owning One Hundred percent (100%) of the outstanding Membership Interests of the Company. A Member's Interest in the Company may not be sold or otherwise transferred except upon the approval of Members owning at least One Hundred Percent (100%) of the Membership Interests of the Company.
- 3. The rights of the Members to withdrawal and the terms and conditions of the withdrawals. If the Operating Agreement is silent as to the aforementioned withdrawal of Members, then the Members of the Company shall have the right to withdraw as a member with (i) six (6) month's prior written notice, and (ii) with the consent of Members owning at least One Hundred percent (100%) of the Membership Interest of the Company. Likewise, there shall be no return of all or a portion of the contributed capital without consent of Members owning at least One Hundred percent (100%) of the Membership Interests of the Company.
- 4. The rights of the remaining members of this Company to continue the business of this Company on the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member, and any other event which may terminate the continued membership in this Company. If the Operating Agreement is silent as the aforementioned, then the remaining members of the Company shall have the right to continue the business of the Company upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member of the Company, upon the approval of any one (1) Member.
