# ARTICLES OF ORGANIZATION OF J&M FINANCIAL, LLC

The undersigned authorized representative hereby executes these Articles of Organization ("Articles") for the purpose of forming a limited liability company in accordance with the laws of the State of Florida.

#### ARTICLE I

#### Name .

Stat.</u>, as the same may be amended from time to time, and as further provided in the Operating Agreement of the Company.

#### ARTICLE VI

#### **Amendment of Articles of Organization**

The Company reserves the right to amend any provision of these Articles of Organization, which amendment shall only be effectuated by the affirmative vote of the members holding fifty-one percent (51%) of the then outstanding membership interest of the Company.
