

Article VII - Members' Capital Contributions

Each Member shall contribute such cash, property or services as set forth in Exhibit "A" hereto as its share of the Initial Capital Contribution.

The Managers may determine from time to time that additional Capital Contributions are necessary or appropriate in connection with the conduct. Members are not obligated to participate. Capital Contributions from Members who do participate shall be recognized in an amended Exhibit "A".

Article VIII

The Net Profits and Net Losses of the LLC for each Fiscal Year will be allocated to the Members in a manner determined by the Managers to reasonably reflect the Members' interests in accordance with the percentage allocations set forth in Exhibit A attached hereto. All distributions of cash or other property shall normally be made to the Members pro rata in proportion to the respective Capital Interests of the members on the record date of such distribution. In certain situations, at the discretion of The Managers, distribution amounts and percentages may be adjusted to reflect contributions of Members disproportionate to their Capital Interests.
